This notice is issued pursuant to Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law.

An Addendum to the Final Environmental Impact Statement (FEIS) has been completed, accepted and filed by the Town of Forestburgh Town Board, as lead agency, for the proposed action described below.

Name of Action: Lost Lake Resort

SEQR Status: Type I

Description of Action:

The Lost Lake Resort is a proposed master planned golf course resort and residential community located in the Town of Forestburgh. The applicant proposes a residential subdivision consisting of 2,557 single-family residential lots, a cluster of 30 single-family cottages, and 40 multi-family townhouse-style condominium dwellings, for a total of 2,627 residences, and associated infrastructure including a private road system, an onsite water supply system, and a wastewater treatment plant. Amenities proposed include an 18-hole championship golf course, a lodge and restaurant, a spa and a variety of recreational uses including open space, parklands, and walking trails, most of which will be open to the general public. The applicant proposes to preserve at least 1040 acres of land defined as open space in the PDD regulation to conserve natural areas and native wildlife habitats. The application seeks to re-designate the zoning district for the project site from RR-1 to Planned Development District. Approvals from various Federal, State and regional agencies will also be required.

Location:

The project site consists of ten tax parcels consisting of 2079.51 acres all owned by Double Diamond, Inc., and located entirely in the Town of Forestburgh in the RR-1 zoning district. St. Joseph's Road (County Route 108) transverses the project site in a west-east orientation and Cold Spring Road (CR 102) passes the northeast corner of the site. The project site is made up of the following tax map parcels: 3-1-1.1, 3-1-2.1, 3-1-3, 4-1-7, 4-1-10.2, 7-1-1, 8-1-1.2, 8-1-2, 20A-1-1, and 20B-1-1.

Responses to DEIS Review Comments of NYSDOT, June 2010

Subsequent to the Town Board acceptance and circulation of the FEIS, the Town became aware of a letter dated June 25, 2010, from New York State Department of Transportation providing its comments on the DEIS. This Addendum to the FEIS consists of this page, which provides responses to the comments raised by NYSDOT, and the June 25, 2010 NYSDOT letter.

1) In Section 1.1.3 "Interested Parties", please include the New York State Department of Transportation as an interested party.

Response: NYSDOT was inadvertently omitted from the list of interested agencies in the DEIS, however, that agency was included in all distributions of the SEQR documents.

2) In Section 1.2.8 "Transportation" and Section 3.8.9 "Traffic Mitigation", it is stated that the Applicant will coordinate with the County to evaluate the traffic conditions [at the project main access] before the start of Phase IV construction. We request that the Applicant include our agency in the coordination with the County.

Response: Before Phase IV construction, the Applicant will coordinate with the County and NYSDOT to evaluate the then-existing traffic conditions at the project main access as requested.

3) In Section 3.8.3 "Future Traffic With the Project", reference is made to the current STIP. Please be advised that a draft STIP for the period October 1st, 2010, to September 30th, 2014, is currently under development. Several of the projects listed in the current STIP have been deferred and moved out of the draft capital program and draft STIP (PINs 901330, 906710, and 906696). The reconstruction of NYS Route 42 from Broadway to Pleasant Street (PIN 901326) is in progress.

Response: Comment noted. This information does not alter the conclusions of the project traffic impact study.
